Preamble:-

Mata Amritanandamayi Math, Amritapuri Post, Kollam District, Kerala had applied to the State Government for issue of No Objection Certificate to its school namely, Amrita Vidyalaya, No. 1179/7, Nijalingappa Layout, Davanagere to get affiliation to the Central Board of Secondary Education, New Delhi, subject to the terms and conditions stipulated therein. However, due to an error in printing/typing the name and address of the institution was not mentioned correctly in the No Objection Certificate dated 7.2.2006 read above and instead the following address was mentioned:-

2. Hence, the NOC dated 7.2.2006 read above, has to be withdrawn and a revised No Objection Certificate, issued in lieu thereof. Accordingly, Government hereby orders as follows:

from time to time as per the provisions of the Karnataka Educational Institutions(Abolition of Capitation Fee) Act, 1984 or as prescribed by the Central Board of Secondary Education, New Delhi.

- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
- (4) Admission to pre- primary stage, should be done in the month of April every year.
- (5) The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the Chambers of the Principal/Head Master/Head Mistress, for the benefit of general public.
- (6) For starting the pre-primary school (Nursery/LKG /UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- (7) Any other conditions that may be imposed in future.
